

TXU Energy Texas Rangers Flyaway Sweepstakes
OFFICIAL RULES

NO PURCHASE NECESSARY. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.

PROMOTION DESCRIPTION: The TXU Energy Texas Rangers Flyaway Sweepstakes (the “**Sweepstakes**”) takes place from April 3, 2026 at 12:00:01 a.m. Central Time (“**CT**”) to May 15, 2026 at 11:59:59 p.m. CT (the “**Sweepstakes Period**”). Entry in the Sweepstakes does not constitute entry into any other promotion, sweepstakes or contest. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of TXU Energy Retail Company LLC, 6555 Sierra Drive, Irving, TX 75039. Rep #10004 (“**Sponsor**”), which shall be final and binding in all respects. The Sweepstakes is in no way sponsored, endorsed, or administered by Instagram. Instagram and Meta, Inc. are completely released of all liability by each entrant in the Sweepstakes.

ELIGIBILITY: Only legal United States residents residing in Texas who are eighteen (18) years of age or older are eligible to enter. Employees, officers and directors of Sponsor, The Promotion House, LLC, (the “**Administrator**”), Rangers Baseball Express, LLC (the “**Rangers**”), their respective parent companies, affiliates, subsidiaries, advertising, and fulfillment and marketing agencies (collectively, “**Sweepstakes Parties**”), the MLB Entities (as defined below), and their immediate families (parent, child, sibling and spouse and their respective spouses, regardless of where they reside) and persons living in the same households as such individuals (whether related or not). HOW IT WORKS:

To enter the Sweepstakes, you'll first need to become a registered user of www.Instagram.com (“**Instagram**”) or log into your Instagram account. If you do not have an account, go to www.Instagram.com to create one. Instagram accounts are free. By submitting your information and creating an Instagram account, you agree to the Instagram’s Terms of Use and Privacy Policy. If you do not agree to such Terms of Use and Privacy Policy, you cannot create an Instagram account or participate in the Sweepstakes. Additionally, to enter, your account must be set to public.

To participate, visit <https://www.instagram.com/reelfanspromo/> (the “**Website**”) and follow the account if you don’t do so already. During the Sweepstakes Period, a “call to action” message (the “**Post**”) will be posted to the Website inviting entrants to comment on the Post by tagging a friend they would take to the game should they be selected as the winner. Comment on the Post with your response and #TXUEnergy_Sweepstakes and you will receive one (1) entry into the Sweepstakes. Each unique comment containing one (1) valid Instagram handle tag will count as one (1) entry into the Sweepstakes. Only tag persons who are known to you and who you have permission to tag for purposes of this Sweepstakes.

By taking any action in response to the Post, you affirm that you have read, understand and agree to these Official Rules. Entrants understand that they are posting at their sole risk. Sponsor is not

responsible for any claims arising from a post, specifically including, but not limited to, claims for intellectual property infringement and privacy rights violations, as well as violations of the respective social media site's terms and conditions.

In the event of a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible. WINNER SELECTION AND NOTIFICATION: At the conclusion of the Sweepstakes Period, a random drawing will be held from among all eligible entries received in accordance with these Official Rules to select one (1) potential Grand Prize winner. The potential winner will be notified via a direct message and/or comment on their post via Instagram. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond as directed within seventy-two (72) hours of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit their prize and an alternate winner may be selected.
